This 2024 contract is for breeding to the KFPS/FHANA registered Friesian stallion Julius 486 Sport Elite AAA, owned by KCF Farms in Ontario, Canada and standing at Cazemier Equine Center in Spencerville, Indiana, USA. This agreement is valid only for the 2024 breeding season. The Mare Owner and KCF Farms/Cazemier Equine Center, LLC agree to the following terms and conditions:

1. **BREEDING:** The Cazemier Equine Center, LLC stands the Friesian stallion known as Julius 486 Sport Elite AAA. Semen shipped is to be used on only the mare provided in this agreement. This agreement cannot be transferred or sold by the Mare Owner. There shall be no right of return to the Live Foal Guarantee if the mare is sold or otherwise changes ownership.
2. **BREEDING FEE:**
 - a. The Breeding Fee for Julius 486 Sport Elite is \$1,500.00 USD.
 - b. The collection and shipping fee is \$385.00 USD when shipping within the USA, and \$550.00 USD when shipping to Canada.
 - c. Saturday delivery incurs an additional \$15.00 USD charge due to increased FedEx fees.
 - d. Payment of the Breeding Fee and Collection/Shipping Fee can be made by PayPal or credit card (there is a 3% transaction fee added for credit cards), and must be received by Cazemier Equine Center, LLC **prior to** the collection and shipment of semen. Mode of payment should be arranged with Cazemier Equine Center, LLC.
 - e. Additional reproductive services are available at Cazemier Equine Center, LLC. These services include (but are not limited to): Mare Boarding, Ultrasound, Artificial Insemination, and Medical Care (shots, flush, cultures, etc.). Mare Owners need to arrange, and will be billed separately for, such services with Cazemier Equine Center, LLC.
3. **BREEDING SEASON:** The Cazemier Equine Center, LLC 2024 breeding season for Julius 486 Sport Elite is from February 1st to August 31st. Cooled semen will be available in the order that contracts have been received. Advanced booking will place your mare at the top of the list for shipped semen. All other semen requests will be on a first come basis.
4. **COOLED SEMEN ORDERS:** Cazemier Equine Center, LLC ships semen **5 days/week, Monday - Friday**. In order for semen to be collected and shipped for timely arrival, semen orders must be called in the day **before** the intended insemination and definitely before **11:00 AM Eastern Time** on the day of the semen collection, in order for the shipment to be picked up from the farm by FedEx at Noon.

Semen orders should be made by telephone to 260-446-4291. Orders canceled after the stallion has been collected will be billed. KCF Farms and Cazemier Equine Center, LLC assumes no responsibility for the loss of semen or semen viability caused by the carrier (FedEx).

The Mare Owner understands that each shipment of semen will contain one dose of semen. A second dose will be included in the shipment only after all orders are filled and additional doses are still available. Priority will be given in the order the contracts were received.

5. **LIVE FOAL GUARANTEE:** Should the mare fail to conceive, abort, or not produce a "Live Foal" (Live Foal shall be defined as a foal that stands and nurses without assistance for a period of at least 24 hours from the time of birth), then KCF Farms guarantees the Mare Owner shall have the right to rebreed or substitute a mare (upon the approval of KCF Farms) **within the current (2024) or the following (2025) breeding season only**.

The Mare Owner shall notify Cazemier Equine Center, LLC **within thirty days** of the last day of the

breeding season if the mare did not conceive, to be eligible for a rebreed. The Mare Owner shall also notify Cazemier Equine Center, LLC within thirty days of the mare's abortion, should the mare abort. If the mare does not produce a "Live Foal", then the **Mare Owner shall provide KCF Farms with a veterinarian's certificate** stating the time and date of birth, time and date of death and cause of death ***within seven calendar days*** of such death.

In the event that the mare dies before or during birthing, the Live Foal Guarantee shall no longer be valid.

The Live Foal Guarantee shall be specifically conditioned upon the Mare Owner's vaccination of the mare for Rhinopneumonitis in the 5th, 7th, and 9th month of the mare's pregnancy. The Mare Owner shall provide **KCF Farms** with the ***certificate stating that such vaccination has taken place*** at the time the Mare Owner requests a rebreed pursuant to this section.

The Live Foal Guarantee shall lapse and KCF Farms shall have no further obligation under this section if:

- a. The Mare Owner fails to rebreed the Mare during the acceptable return breeding periods as defined in this section (within the current (2024) or the following (2025) breeding season).
- b. The Mare Owner fails to provide a Rhinopneumonitis vaccination certificate.
- c. The Mare is bred by another stallion without written consent by KCF Farms.
- d. The Mare is substituted with another mare without written consent by KCF Farms.
- e. The Mare fails to conceive or aborts and the Mare Owner fails to notify KCF Farms or Cazemier Equine Center LLC, as defined in this section.
- f. The Foal dies due to lack of supervision or proper facilities during the birthing process.
- g. The Foal dies due to any negligent act of the Mare Owner.

If the mare (or a substitute mare) does not become pregnant within two breeding seasons, (that is, the breeding season during which this contract is signed and the next consecutive breeding season), the Live Foal Guarantee expires and the Mare Owner forfeits all fees associated with this breeding that were paid to KCF Farms and Cazemier Equine Center, LLC. Under particular circumstances, KCF Farms may choose to allow the deferral of a Live Foal Guarantee for a period of time, however the Mare Owner must obtain explicit written permission from KCF Farms under such circumstances.

The Live Foal Guarantee in this contract is non-transferable and non-assignable and should the mare be sold or otherwise disposed of prior to the birth of the foal, the Live Foal Guarantee shall be void. The Mare Owner shall not be entitled to a refund of prepaid fees except if the stallion should die or become unfit for service prior to serving the mare in the present breeding season. Once the mare has been serviced, there will be no refunds of any kind. Should the stallion die after the mare has been serviced, the Live Foal Guarantee shall become void.

6. KCF Farms and Cazemier Equine Center, LLC cannot be held responsible in any way for any illness or injury to a mare or to any other horse due to the breeding with this Stallion, nor for a mare's failure to conceive. It is understood that KCF Farms and Cazemier Equine Center, LLC their employees, veterinarians, and guests shall not be liable for any injury, escape, disability, or death of any horse related to this breeding.
7. The Mare Owner should have their mare checked for pregnancy at approximately 15 days after ovulation. This allows for time to handle any issues around possible twin embryos as well as to give the Mare Owner and Cazemier Equine Center, LLC time to prepare for the next breeding cycle if the mare did not settle.
8. Birth Announcement forms for 2025 foals will be available online via the KFPS website using your KFPS login and password. This service provided by the KFPS is ***solely dependant on the Mare Owner returning this completed and signed contract to Cazemier Equine Center, LLC.*** KCF Farms and

Cazemier Equine Center, LLC can not guarantee the Mare Owner will have the ability to register their foal if a completed contract is not submitted by the Mare Owner.

9. The laws of the State of Indiana govern this contract.
10. The Mare Owner acknowledges full agreement with this breeding contract by signing and returning this contract to Cazemier Equine Center, LLC.
